WHEREAS, The Interstate Traveler Project is an elevated maglev (magnetic levitation) rail mass transit system that is based upon a conduit cluster concept powered by hydrogen and solar power. The project promises to provide travelers with a clean, quiet, safe, reliable mode of transportation. The intent of the project is to create the world's first switchable maglev rail network that will provide inter-urban/inter-city pedestrian, automobile, and light freight transit services. The project will simultaneously produce, store, and distribute hydrogen, which will not only serve as an alternative energy resource, but also will give Michigan's automakers the incentive to produce hydrogen internal combustion engines, fuel cell cars, and the manufacturing opportunity to build maglev rail cars; and

I am writing to offer my support and to inform you of the support of the Michigan Legislature, as indicated by House Resolution 23, Senate Resolution 89 and boilerplate language in the 2004 Transportation Budget bill (Senate Bill 265, Sec. 728), regarding an alternative multi-modal magnetic levitation rail passenger service concept (a.k.a., Interstate Traveler Project).

Not only is this concept new and innovative (vehicles powered by solar energy/hydrogen/fuel cell technology on mag/lev rails within existing rights-of way), it has all the markings of being a self-sufficient public transportation provider that could also generate revenue for the state, considering all of the other deliverables (hydrogen, communication, utilities, drinking water, etc.) associated with the mag/lev rail design. This project also has the potential for addressing the hydrogen/fuel cell passenger vehicle question . . . why build hydrogen passenger vehicles if there is no hydrogen distribution network?

It is my understanding that after a brief research and development phase (which will also provide assurances to the Legislature, Administration and MDOT regarding this public/private partnership), the Interstate Traveler Company, LLC (inventor of the Interstate Traveler Project) could move quickly into the pilot phase of the project.

This project/concept has indeed captured the interest of the Michigan Legislature, Federal Government Officials, Local Units of Government, Planning Organizations around the state, as well as other states and counties. If we are truly interested in providing clean, inexpensive, reliable rail transportation for the citizens of Michigan and beginning the hydrogen energy source conversion for passenger vehicle, this is a perfect opportunity for Michigan to invest some of its resources in this new mode of transportation.

This new and innovative project could place Michigan on the global leading edge of public transportation, hydrogen distribution and would be an excellent use of research and development funds.



I'm so sorry I missed your visit to my office, but I would really appreciate the chance to catch up with you soon. I presume that life back in Michigan is treating you at least as well as work in the House. However, thank you for passing on your useful information on the solar/hydrogen powered maglev rail project.

As you may know, I share your keen interest in alternative energy sources, and have made the pursuit of an American transportation system based on clean and renewable fuel a legislative priority. That is why I introduced the H2GROW Act, H.R. 1180, to significantly aid the development and deployment of hydrogen fuel cell cars and hydrogen fueling stations.

In addition to increased energy efficiency, fuel cell cars will significantly reduce the pollution produced by our transportation system. The U.S. Department of Energy projects that if 10% of automobiles nationwide were powered by fuel cells, regulated air pollutants would be cut by one million tons per year.

Thank you again for sharing this information, Dick. As always, my office is available to assist you.

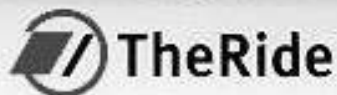
